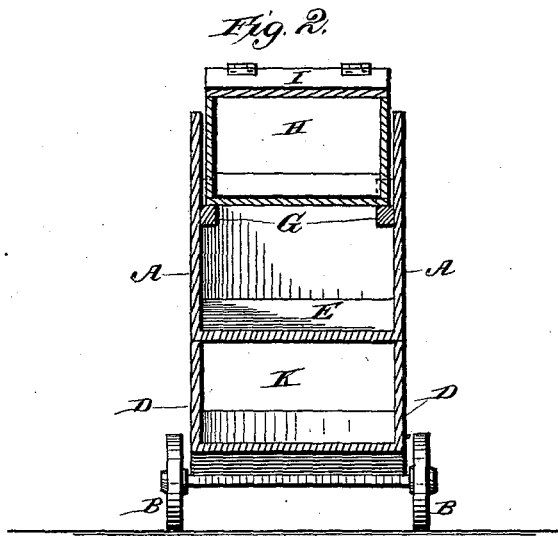
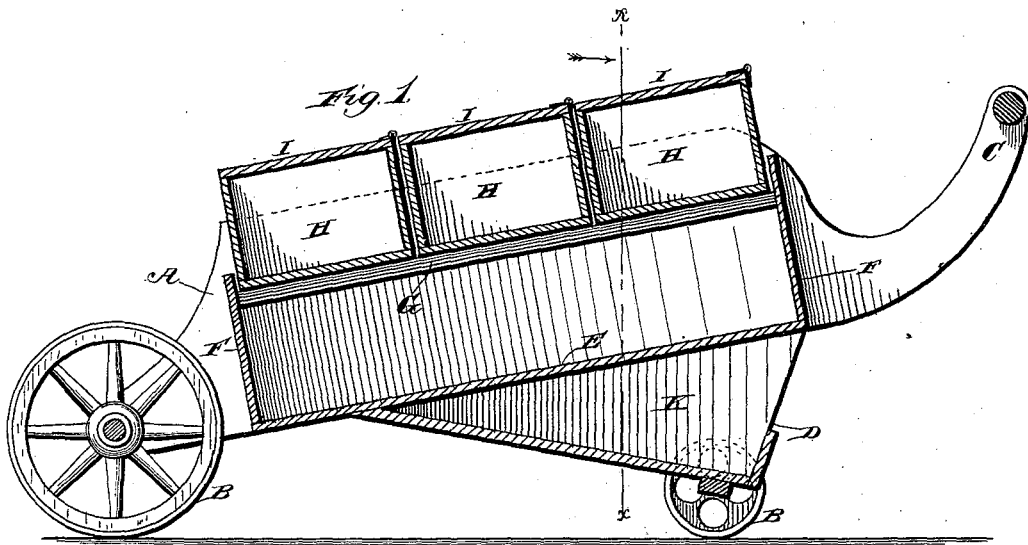

AMANDA MORRISON, OF WILMINGTON, NORTH CAROLINA.

MARKET-TRUCK.

SPECIFICATION forming part of Letters Patent No. 284,881, dated September 11, 1883.

Application filed March 12, 1883. (No model.)

To all whom it may concern:

Be it known that I, AMANDA MORRISON, a citizen of the United States, residing at Wilmington, in the county of New Hanover and State of North Carolina, have invented certain new and useful Improvements in Market-Trucks, of which the following is a specification, reference being had therein to the accompanying drawings.

10 This invention has for its objects to produce a handbarrow or wheelbarrow in which there will be more available room than heretofore, which will be compact and strong, and which will be particularly applicable to the wants of
15 grocers, market-dealers, truck-dealers, and others who find it necessary to distribute a variety of different articles, and who may find it desirable or convenient to keep such articles separate without putting the same up in pack-
20 ages, thus saving the time and trouble necessary to thus put them up, while the articles are in condition to be readily measured out and distributed in quantities as may be required. These objects I attain by the apparatus and devices illustrated in the accompa-
25 nying drawings, in which—

Figure 1 represents a longitudinal vertical section, and Fig. 2 a transverse vertical section, of my improved apparatus.

30 The letter A indicates the body, which is mounted upon a wheel or wheels, B, at one end, and at the other is provided with the usual handles, C. The lower sides of the barrow slope from the legs D to the opposite end of said barrow, for the purpose hereinafter described.

The letter E indicates a partition or the

bottom proper of the apparatus, which, with the sides A and ends F, forms a receptacle for articles in bulk, the said receptacle forming
40 the main compartment of the barrow. Near the upper edges, on the inside of this receptacle, are secured the cleats G, which form a seat and support for a series of receptacles or boxes, H, which are provided with hinged
45 covers I. The said boxes serve to close the receptacle or main compartment of the barrow, and at the same time to hold articles of various descriptions. Below the partition or
50 bottom E is an inclined partition forming a receptacle or compartment, K, below the main compartment. This compartment is open at one end for the reception of articles.

It will be observed that as thus constructed the entire space between the sides is utilized,
55 and a compact and convenient barrow is produced, and which is particularly applicable to the uses above enumerated.

Having thus fully described my invention, what I claim, and desire to secure by Letters
60 Patent, is—

A hand or wheel barrow with a main compartment and an angular compartment below, the main compartment being provided with a seat near its upper edges for a series of recep-
65 tacles or boxes which serve to close the main compartment as well as to hold articles, substantially as specified.
